SUBJECT: Postponement of Notification amending Packaged Commodities Rules under Legal Metrology Act - for Green and Brown dot for cosmetics issued by MoCA.

Respected sir,

Greetings from Retailers Association of India (RAI)!

It is my pleasure to write to you on behalf of RAI.

This is with reference to the notification issued by the Ministry of Consumer Affairs dated 16<sup>th</sup> June, 2014 with regards to cosmetic products and toiletries bearing Red or Brown dots for non-vegetarian and green dot for vegetarian products.

A few of our member retailers received notices from the Local Legal Metrology departments for selling/ storing products in violation of the said Notification. You will appreciate the Notification has raised more questions than it answered, namely:

- Retailers purchase goods for sale from manufacturers/ distributors/ importers whose primary duty is to comply with this new Rule. However, our member-retailers are receiving regularly products that are violating the Notification and its conditions since manufacturers' pipeline is planned months in advance, like our members' purchases, hence such products will flood the market for at least another 6 to 9 months.
- 2. Manufacturers' labels are pre-designed, printed, and kept ready months in advance. Therefore complying with this Notification means that such inventory running into crores of rupees, should be wasted or destroyed. We sincerely hope that the intent of the Ministry in issuing this Notification was not to waste such valuable national resource.
